**Mr Peter Garrisson SC**  
*Solicitor-General for the ACT*



Peter Garrisson SC is the Solicitor-General for the Australian Capital Territory, also performing the functions of Chief Solicitor, and is thereby responsible for the management and legal affairs of the ACT Government Solicitor's office. He was admitted to legal practice in 1981 in Melbourne and practised in private practice until 1995. He worked with the Australian Securities and Investments Commission where he was a Regional Commissioner until 1999. Peter moved to Canberra and joined the ACT Government Solicitor's office in 1999.

He has significant experience in commercial law including contracts, intellectual property, trade practices, corporations law and insurance. He has acted for the ACT Government in a range of major commercial transactions and regularly advises on complex commercial and governmental matters.

Peter has practised widely in commercial litigation and dispute resolution, and has extensive expertise in land law and legal interpretation. He advises the government on complex constitutional and public law matters, including matters arising under the *Human Rights Act 2004*, and appears as counsel for the Attorney General. Peter was Chief Solicitor from 2004 until his appointment as the ACT's first Solicitor-General in August 2011 and was appointed Senior Counsel in 2013.

Dr Loretta Zamprogno conducts a commercial practice, and is responsible for the management of the property and commercial practices within ACTGS. Loretta has experience in government procurement and contracting, acting as the Territory's legal adviser on significant matters.
